From Your Chapter Secretary



Minutes of the February 21 Chapter Meeting

- 1) The meeting was called to order by President Kindt at 7:02 PM on Tuesday, February 21, 2012.
- 2) President Kindt led the chapter membership in a recitation of the Pledge of Allegiance and called for a moment of silence for our brother Blue Knights in need.
- 3) **Introduction of new members/special guests.** Director Chuck Homa introduced prospective members Mark and Christine Koch, both retired MPD officers.
- 4) Reading of the minutes of the last meeting (01/17/12). A motion to waive the reading of the minutes was made by Chuck Homa and seconded by Jim Bagurdes. The motion passed with one opposed.
- 5) **Treasurer's report.** Treasurer Bortmess read his monthly financial report (the contents of which will not be published in this forum). There was no discussion regarding the report. A motion to accept the report as published was made by Mike Zivicki and seconded by Robert McDermott. The motion passed.
- 6) **Quartermaster's report.** Quartermaster Bagurdes stated he had nothing new to report. He did state that he had received some bottles of booze for the booze raffle. President Kindt stated that it is important that members donate at least 2 bottles for the raffle, and initially stated that there was one more meeting before the event (corrected-there are two more meetings before the dance) and members are encouraged to bring their donations to the meetings and get them to Jim Bagurdes.

7) Old business.

- A) **2012 Dance.** Co-Chairperson Santoro provided the report (Co-Chairperson Fisher-Waliszewski was not present). She stated that she has admission tickets for anyone who wanted to sell them. She also stated that they are still in need of door prizes. She stated she can e-mail donation letters and dance flyers to anyone who wants them. Jim Bagurdes stated that he has booze raffle tickets.
- B) **2012 Secondary Charity Committee.** Committee Chairperson Kristi Bleickardt announced the organizations the chapter was donating to and the amounts they will receive. They are: Stars and Stripes Honor Flight (\$200), Blue Knights COPSRUN (\$200), Fisher House of Wisconsin (\$200), Holiday Lake Area Shop with Cops (\$100), and Special Olympics (\$100). After brief discussion Secretary Hafeman stated he would obtain the checks from Treasurer Bortmess and send out the donation letters and checks.
- C) Joe Kubicek spoke briefly regarding the 2013 Spring GLRC, which is being hosted by WI VI. He stated that he will be meeting with the host hotel on March 3 to sign the contract. He had no further information at this time.
- D) There was no additional old business discussed.

8) New business.

A) International/GLRC updates. Secretary Hafeman stated that at the last International Board of Directors meeting several proposals were discussed and voted on. Proposal 2011-003 regarding an increase in membership dues had already been passed. Author Koen Hutse from the European Conference was directed to draft a resolution which will be voted on at the General Membership meeting as this proposal requires a bylaw change. Proposal 2011-0013 addressed outsourcing the International officer election to an independent company. This proposal was tabled. Proposal 2012-001 was a request by PA 18 to leave the Tri State Conference and join the GLRC. The motion was defeated (4 for, 8 against, 4 abstaining). Joe Kubicek explained that PA 18 and NY 26, both members of the Tri State Conference, have payed conference dues to the GLRC and are considered associate members of the GLRC. Proposal 2012-002 was a request for CO 3 to leave the Southwest Conference and rejoin the West Coast Conference. The proposal was withdrawn after the proposal regarding PA 18 was defeated. Proposal

2012-003 was for the acceptance of a donated 2.5 acre parcel of land in Maine. Initially the proposal passed (12 for, 3 against), however this was unanimously overturned on 1-26-12 when it was found that the land was only valued at \$1,300.00 and the club would be unable to develop the land or build on it. Proposal 2012-004 was a housekeeping proposal, dealing with a chapter having their sales item left out of the International Sales Catalog. The proposal passed (13 for, 2 against). Proposal 2012-005 was a request by the European Conference to bid for the 2014 International Convention outside of the traditional third week of July. They are requesting to host the convention from June 22-29, 2014. The proposal passed (14 for, 1 against), however it was amended to state that any chapter bidding for the 2014 International Convention can host it any week in June or July; this change only affects the 2014 convention. Proposal 2012-006 regarded setting up a recruiting booth during Law Week in Washington DC at a cost of \$3,000.00. The proposal passed (12 for, 2 against, 1 abstention).

- **B)** Ted Engelbart stated that he and Al Schoessow discussed recruiting new members. He suggested publishing a recruiting article in The Badge and the Sheriff's Department newsletter. After brief discussion Joe Kubicek stated he would send the contact information for The Badge to Vice President Karwacki and Secretary Hafeman.
- C) There was no additional new business discussed.
- 9) Announcements/Good of the Order.
 - **A)** Secretary Hafeman read an e-mail from Lori Bednarek thanking member Jim Bagurdes and the membership of WI VI for locating an old style MPD patch for her. The patch is a gift for her husband, who is a Blue Knight in Indiana.
 - **B**) Secretary Hafeman read an e-mail regarding a sponsored charity ride. Carolyn Barns, the wife of a BK Wales 1 member is riding from the UK to Bansang Hospital in Gambia, Africa on a Honda C90 scooter. The trip is 4,000 miles. Anyone wishing to make a donation can do so on their web site: www.scootersinthesahara.co.uk.
 - C) President Kindt again stressed the upcoming dance. He stated that at this meeting the secondary charitable fund was depleted and two other large donations to injured officers were being made. He stressed the necessity of raising money to replenish these two funds, reiterating seeking out donations and selling tickets.
 - **D)** Secretary Hafeman stated that the 2012 membership cards are in. He asked all the members who received their cards check them over for accuracy. Bob McDermott stated that several years ago he asked the International President if the date you joined the Blue Knights could be included on the card. He was informed that this could be done; Bob stated that it still hasn't. It was pointed out by Joe Kubicek that the year a member joined the Blue Knights in on the front of the membership card.
 - E) Bob McDermott stated that he called Bessie at the International Office regarding the Blue Knights credit card, and was informed that the card was no longer available. He also stated that this year he will have been a member of the Blue Knights for 34 years and will be 75 years old. He received a round of applause.
 - **F)** Joe Kubicek stated that there are two new bottles of scotch being featured by Alioto's. They were recently added to their stock at his suggestion. He encouraged the membership to indulge "Dutch treat."
 - G) There were no further announcements made or information discussed.
- 10) Next meeting date: Tuesday, March 20, 2012 at 7:00 PM at Alioto's.
- 11) The 50/50 drawing was held, with \$60 being won by Dennis Hafeman and \$60 going to the chapter treasury.
- 12) A motion to close the meeting was made by Tom Listinsky and seconded by Joe Kubicek. The meeting was officially closed by President Kindt at 7:24 PM.
