### **GLRC & INTERNATIONAL UPDATES:**

Here is a summary from the last board meeting on May 14<sup>th</sup> from the International Rep.

- -Audit....or should I say "lack of." The RFP's have expired and after some changes to the RFP's, only one firm has shown interest.
- -Joe Kubicek stepped down as chairman.
- -Proposal to amend by-laws regarding the Canadian Correctional Officers failed
- -The BOG reported they only have 1 bid for the 2016 International. PA V, out of Harrisburg PA. Dates of June 17-24<sup>th</sup> 2016. Registration is \$110.00. This is in the Hersey PA area.
- -The BOG meeting is coming up June 23<sup>rd</sup> and our President Tiny will be voting at that one.

At this meeting there will be a discussion and vote regarding an amendment of the bylaws to allow proxy voting. How this will work is, any regular member can get a letter from any other chapter to vote on their behalf.

Dennis explained that how this proposal is written up one member could walk in with 25 letters, from 25 chapters, and be 25 voting members.....that could influence how things go. If you want more details see Dennis after the meeting, (it is a three page proposal.)
