Minutes of the Chapter Meeting

- 1) The chapter meeting was called to order by President Kindt on Tuesday, October 18, 2011 at 7:02 PM.
- 2) President Kindt led the membership in a recitation of the Pledge of Allegiance, followed by a moment of silence for our brothers in need. President Kindt also added a moment of silence for Founding Father Wayne Labree who recently passed away. Vice President Karwacki informed the membership that cards for members Steve Schultz and Pete Simet were being passed around for members to sign. Both are recovering from medical issues (more information later under announcements).
- 3) Introduction of new members/guests. Ted Engelbart introduced guest Jim Shutes.
- 4) Reading of the minutes (September 20, 2011): Secretary Hafeman stated that Joe Kubicek indicated an error in the last meeting minutes. Under old business-2012 Sweetheart's Dance it was reported that "Debut Printing" handled the booze raffle tickets. The correct company name is Bay View Printing. No other corrections to the minutes were indicated. A motion was made to accept the minutes as published with this correction by Bob McDermott and seconded by Mike Stroessner. Motion passed.
- 5) **Treasurer's report:** Treasurer Bortmess read his October 2011 report. Final numbers will not be published in this forum. A motion to accept the treasurer's report was made by Bob McDermott and seconded by Sandy Santoro. Motion passed.

6) Old Business:

- A) 2012 Sweethearts Dance. Co-Chairperson Santoro stated that Kim was home sick. The hall for the dance has been booked, and the date will be Saturday, April 28, 2012. The dance will be held at the Knights of Columbus, 3200 S. 103 St. (Greenfield). There was discussion relative to the name, as the event is not being held in conjunction to Valentine's Day. It was suggested being named "Blue Knights Annual Fund Raiser." There is no theme in mind for the event, so President Kindt directed the Dance Committee to pick an appropriate name. Members are strongly encouraged to begin getting raffle items and door prizes. Co-Chairperson Santoro stated that she would work on getting tickets. President Kindt informed her that Treasurer Bortmess still has the raffle license number. Booze Raffle Coordinator Jim Bagurdes stated he would get booze raffle tickets printed and would also check into having admission tickets printed. Joe Kubicek stated that in the past Kevin Porter had been able to get the admission tickets printed for the chapter. There was discussion relative to the cost of admission, and it was decided that the cost would remain \$10.00 for advance tickets and \$12.00 for tickets at the door. President Kindt asked that **all members** donate at least three bottles of quality liquor for the booze raffle. Joe Kubicek also stated that in the future we should consider asking restaurants we patronize for brunch and dinner rides for booze donations. Co-Chairperson Santoro stated she will e-mail donation letters out very soon.
- **B)** Blue Knight of the Year: Current BK of the Year Sandy Santoro asked the board when she should return the traveling plaque. Secretary Hafeman asked her to return the plaque to him by December so it could be engraved with the next recipient's name. President Kindt stated that nominations for the 2011 BK of the Year should be e-mailed

to any executive board member, along with a brief explanation why that member should be awarded. The presentation will take place at the annual chapter Christmas party.

C) Crying Towel Classic II: Joe Kubicek stated that round two of the Packers/Bears game takes place Christmas Day at 7:30 PM. He stated that while most members have family obligations that night, there is still interest in getting together for the game. He stated that he and Doni as well as some members of IL X are planning to watch the game. Joe asked that anyone interested in getting together for the game contact him. There was some discussion about meeting with IL X on a different date.

There was no further old business discussed.

- 7) New business:
- **A) International/GLRC updates:** Secretary Hafeman stated that the only update he had was relative to the death of Founding Father and Second International President Wayne Labree. He passed away at 5:00 PM on October 11 in Florida.
- B) WI VI Christmas Party: Secretary Hafeman asked the membership if the membership wanted a Christmas party; the answer was a resounding yes. Secretary Hafeman stated that he wanted to begin working on this due to the fact that Packers playoffs last year prevented the rental of the MPSO Union Hall. A venue for the party was discussed, and it was decided to rent the MPSO Union Hall again, with possible dates of January 7 or 14, 2012. Secretary Hafeman stated he would handle this, and would have a firm date for the party by the November meeting. He would also contact George Markopoulos about food. It was suggested inviting the members of IL X.

There was no further new business discussed.

8) Announcements/Good of the order: President Kindt stated that he had received an email from the Vice President of Belgium XI. This member was interested in patches; the e-mail asked for donations, not trading. President Kindt stated that if anyone was interested in this they contact him for the information.

President Kindt spoke about the upcoming 2012 Spring GLRC. The event will be held in Niagara Falls, NY from March 30-April 1, 2012. The host hotel is on the American side of the falls; you will need your passport if you want to go to the casino on the Canadian side.

Secretary Hafeman stated that at the last meeting he had announced that the 2012 Fall Midwest Regional Conference was tentatively being held in Olathe, Kansas again. He stated that on the MWRC web site it was announced that the 2012 Fall MWRC will be held in Omaha, Nebraska (hosted by NE II) on September 7-9. There was no further information. Secretary Hafeman stated that Janis Smolinski had requested the dates of 2012 BK events, and due to that request he would publish the dates and information for these events starting with the October chapter newsletter.

Joe Kubicek spoke about the 2012 Spring MWRC, which will be in Winona, Minnesota from June 8-10. Winona is approximately 4 hours away (Lacrosse area). Joe stated that the host chapter (MN I) will be opening the hospitality suite on Thursday night for anyone arriving a day early; this is included in the registration fee as well. He further stated that early arrivals are becoming more common for BK conventions. He encouraged members to attend these conventions, stating they are as much fun as events in the GLRC.

Chuck Homa gave an update on Pete Simet. Pete had recently undergone surgery and unfortunately experienced complications. Bob Barr stated that "Big" Steve Schultz had also undergone recent surgery and like Pete experienced complications. Currently both are at home recovering. **Out of respect for their privacy I will not publish the details of their illnesses** Get well soon cards were passed around the membership for signature, and Secretary Hafeman stated he would mail them.

Vice President Karwacki stated that he ran into past member John Karlovich at the Bay View Library. John's health is improving, although he is still undergoing treatment. He had sold his motorcycle, and is looking into purchasing a trike and returning to the club.

Bob Barr spoke about the recent fall colors ride. He stated that about 40 people and 30 bikes showed up for the ride. The weather was excellent. He further stated that Gary Davey's trike broke down, and Sandy Santoro had experienced problems with her bike. Bob stated that he will be unavailable for leading a brunch ride on November 13, and asked that someone else step up to lead it.

President Kindt stated that anyone with photos of BK events get those to him on a flash drive or CD. He wants to put together a slide show to display at chapter events such as the Christmas party or our GLRC.

There were no further announcements.

- 9) Next meeting will be held on Tuesday, November 15, 2011 at 7:00 PM at Alioto's.
- 10) The 50/50 was drawn, with \$50 going to winner Bob Barr and \$50 going to the chapter.
- **11**) A motion to close the meeting was made by Chuck Homa, and seconded by Ted Engelbart. President Kindt closed the meeting at 7:35 PM.
